Cllr Warner opened the meeting at 7.50 pm following the Annual Parish Meeting at 7.00pm

- 1. Apologies: Cllr. Tuely, Cllr Parsons, Cllr Seymour .
- 2. Disclosure of Interests and Election of Chairman and Vice Chairman: There were no Disclosures of Interest. Cllr Tuely was re-elected as Chairman (proposed by AW and seconded by PL) and Cllr Andy Warner re-elected as Vice Chairman (proposed TL and seconded by DB).
- 3. Approval of Minutes of the Extraordinary Parish Council Meeting of Monday 28th April 2014

There were no objections.

The Minutes of 28th April were unanimously approved and signed as a correct record of the meeting

- 4. Matters arising from the Minutes which are not covered elsewhere:
 - Defibrillator: The defibrillator is now installed in the Church porch. Dick Tracey can come to give a training session on Sat 28th June 9.30 11.30 am in the Church. Notices to be put up on notice board, shop, church porch and Killingworth Castle Clerk
- 5. County Council and District Council Matters; Unfortunately Cllr Hudspeth had to leave early to attend a meeting at Tackley. He continues as Leader of the Council and has appointed a cabinet with 50% female members. The news in the Summer of a further reduction in government spending meant that savings of an additional £64 million had to be found. Knowing the budget would be difficult he carried out a series of meetings around the county called 'Talking Oxfordshire', one of which was attended by Cllr Tuely. Of direct relevance to Wootton: Home to School Transport no student who currently or will receive free transport from Sept 2014 will have it withdrawn. Students will still receive free transport but only to the nearest school. Broadband over 92% premises connected by the end of 2015. Strategic Housing Market Settlement: target for West Oxfordshire going from 305 pa to 660-680 pa. This will have an impact n the Local Development Framework as new sites will have to be identified across the District and from a County Council perspective, it is vital there is the correct

infrastructure in place, especially highways and education. **Positive accouncements:** additional investment of £800,00 to enable 15 minute care visits to be extended; £1m for extra general highway maintenance spent across the county; A total of £400,000 set aside as a contingency to deal with flooding and winter weather issues; A total of £315,00 will be invested in community budgets.
