69/24 Apologies and Declarations

70.1 Minutes of the meeting held on 4 December 2023 were approved and accepted into record and signed by the Chair.

71/24 Open forum

71.1 County Councillor: Cllr Andy Graham

Cllr Andy Graham reported that measures to improve road safety in Woodstock speeding in Woodstock will go for decision on 25 January. He said the decision will take account of the local consultation. If the measures are approved, they will be implemented by May/June. Pedestrian safety is the highest priority with lower speed limits likely through the town. There is no longer any pressure to turn the buses in the centre of Woodstock so that safety issue seems to have been resolved. He also reported that a new scheme was being developed to move the library to a new community hub with a low-cost housing element. The car parking and public toilets will be improved at the same time.

71.2 District Councillor: Cllr Tim Sumner

He stressed the importance of responding to the Botley West consultation. He also reported that WODC are seeking feedback on how wellbeing and leisure

services could be developed and improved, in particular how they could be improved in rural areas. There is a survey on the WODC website. Advice was offered by councillors on how WODC could draw attention to this survey. Finally, Cllr Sumner said that 2024 will see a lot of national issues aired but confirmed his personal commitment to local communities and said that he believed that the value of localism and local communities would be increasingly recognised.

Cllr Mackinlay is following up the outcome of testing being carried out by Sheenans and will also check on the situation with Japanese Knotweed.

There is good representation from all parts of the village including 16-19 year olds who will report back and provide questions.
